Please check the "Change in value of personal property" box on page 2 and return this notice to our office by **March 2, 2018.** Upon receipt of the returned form, we will mail you a Form 571-STR for you to report the cost of business personal property on your short-term rental business. The last day to file the form is April 2, 2018. The last day to file without incurring a penalty is May 7, 2018; the penalty for filing after May 7, 2018 is 10% of the total assessed value.
