There, you can e-File the Form 571-L or you can download the form and mail a completed statement to our office. Please read the instructions below for more information on this process.

#### **Instructions for Completing the Form 571-L**

Our office will begin accepting e-Filed statements through our online portal on **February 20, 2018**. To begin this process, visit <a href="www.sfassessor.org/efile">www.sfassessor.org/efile</a> and log in using the Account Number and PIN at the top of this Notice. The Account Number and PIN are unique to your business, provide secure access to your statement, guard your confidential information, and protect your privacy.

Please remember that the PIN is case sensitive, is only good for this year and is non-transferable. If you lost your PIN, you may retrieve it by going to the e-File logon page and select <u>Forgot My PIN</u>.

Once you are logged in, choose your preferred filing option and follow the instructions on the online portal:

(1) <u>E-File Directly Online:</u> E-File is a free online application that allows businesses to file the Form 571-L quickly and securely. No new software is needed to e-File, and e-Filing allows businesses to receive an immediate online

confirmation once a statement is submitted. In addition, once a business has e-Filed, prior year e-Filed statements will be viewable online. Visit <a href="https://www.sfassessor.org/efile">www.sfassessor.org/efile</a> and log in to begin the process.

(2) <u>Download, Print, Complete, Sign and Mail:</u> Businesses may also submit the Form 571-L by mail.
